In exercise of the powers conferred under the sub-section (1) and sub-section (2) of Section 28 of the Water (Prevention and Control of Pollution) Act, 1974 (6 of 1974) and sub-section (1) and (2) of section 31 of the Air (Prevention and Control of Pollution) Act, 1981 (14 of 1981), Sri Justice J.P. Das, Former Judge of Hon'ble High Court of Orissa is hereby appointed as the Vice-Chairman to the Appellate Authorities constituted by the Government of Odisha in the Forest and Environment Department vide Notification No.22403/F&E, dated 19.11.2019 and No.22397/F&E, dated 19.11.2019 to assist the Chairman, to hear appeals preferred against the order made by the State Pollution Control Board, Odisha under the said Acts, respectively.

1. The tenure of the Office of the Hon'ble Vice-Chairman shall be of one(1) year from the date of his joining.
2. The existing staff of Hon'ble Chairman of Appellate Authority will assist the Hon'ble Vice Chairman to discharge his function in the Appellate Authority.
3. The remuneration of the Hon'ble Vice-Chairman shall be Rs.1,30,000/- per month i.e. Pay - Pension of a Retired Judge of High Court.
