
No.: **FE-ENV2-ENV-0011-2017-23162** /FE&CC, Bhubaneswar, In exercise of the powers conferred by sub-section (1) and (2) of Section-31 of the Air (Prevention and Control of Pollution) Act, 1981 and in suppression of this Department Notification No. Env-I-20/2002/13571/F&E, dated 14.08.2003; No. Env-I-7/2004 (Pt.-III)/10660/F&E, dated 17.06.2005; No. ENV-II-17/2016-21224/F&E, dated 17.11.2016; No. ENV-II-35/2019-22397/F&E dated 19.11.2019 along with partial modification to the Notification No. FE-ENV2-ENV-0011-2017-9877/FE&CC, dated 12.05.2023, the State Government do hereby appoint **Hon'ble Shri Justice S.K. Sahoo**, Judge of the Orissa High Court, Cuttack as the Chairman of the Appellate Authority pursuant to sub-section (1) and (2) of Section-31 of the Air (Prevention and Control of Pollution) Act, 1981, in place of Hon'ble Dr. Justice B.R. Sarangi, who has retired from his position as Chief Justice of the Jharkhand High Court.

Consequently, the composition of the Appellate Authority is hereby amended to the following effect, who will hear appeals against any orders issued by the State Pollution Control Board, Odisha under this Act:
